- 7) That at the time of education no donations are to be demanded or accept such donations. That the Classes which are to be newly started should be recommended by Principal Court Order and government findings.
- 8) That the schools or the society shall not accept any kind of donation in monetary or in kind from the students, parents and the staff. As applicable under Maharashtra Education Society(Prevention of Capitation Fee), Rule

- 9) The School Society shall abide the Rules as mentioned. Compliance of Orders declared by Secondary School Employees Rule 1977 and Maharashtra Primary School Staff Rules & Regulations 1981. Compliance of formalities in the Free & Compulsory Education to Children Act, 2009.
- 10) The School shall fill in the vacant seats of the teaching and non-teaching staff as per government G.R. and that the backward class reservation must be considered.
- 11) Every year the government approval must be taken.
- 12) All the books of accounts and other registers are to be maintained and kept in the office.
- 13) The environment, well built building, sophisticated library, laboratory, staff room must be provided by the proposed school or society.

14) As per government G.R. PTA/2010(347/10), Secondary Education 2, dated 24.08.2010, that as per mentioned there must be teacher and parent committee must be formed and that a school education committee must be formed and that there must be at least 6 meetings must be conducted and the minutes of the meeting must be recorded.

15) Education standard, Educational facilities, Health facilities are to be provided to the students. That there must be separate laterin and bathroom for the girls and boys depending upon the students. Well cleaned water facility, recreation ground must be provided to the students.

16) The school should not collect excess fees nor make compulsory for students to pay the fees without prior sanction from the government. Fire compliance to be completed from the Fire Department and that the health and hygienity and that precautions be taken for any accident, Fire Fighting Equipments must be installed on each floor.

- 20) That the permission of the school is given and recorded under Self-Aided School and binded under the Rule Establishment & ....., Rule 2012.
- 21) The building is safe under government GR, dated 03.11.2009, as mentioned in the National Building Code, as per Supreme Court Order.
- 22) That the pay scale of staff and other amenities must be provided as per Non-Aided School, and that should not be less than the
